TERMS & CONDITIONS

Introduction

1. By entering the “Balthazar Christmas Calendar Competition” (the “Competition”), you accept and agree to be bound by these terms and conditions (these “Terms and Conditions”). Promotional materials relating to the Competition, including all entry instructions, also form part of these Terms and Conditions. In the event of any conflict between any terms referred to in such promotional materials and these Terms and Conditions, these Terms and Conditions take precedence.

2. The promoter of this Competition (sponsor) is Moët Hennessy Danmark (hereinafter referred to as “MHDK”) with a company number of 27960197 and a registered address at Langebrogade 6A, 1411 Copenhagen, Denmark

Entry to the Competition

1. The Competition is open only to legal residents of the Denmark who are of legal drinking age (eighteen (18) years old or over).
2. The Competition starts on 1st of December 2022 and ends on 24th of December 2022 at Midnight (the “Competition Period”). Entries received outside of the Competition Period will not be eligible to win a prize.
3. The prize will be awarded until 31st of January 2023, and the price can be enjoyed at Balthazar Champagne Bar.
4. The Competition will be hosted on the Balthazar Champagne Bar Denmark Instagram Page and will also be promoted on Facebook at the following URL address (though without the possibility to participate directly on Facebook): <https://www.facebook.com/balthazarcph/>
5. Participants can enter via Instagram during the Competition Period at <https://www.instagram.com/balthazarcph/> by following the BalthazarCph Instagram Account and liking the post.
6. Entries submitted by any other means than those described in these Terms and Conditions will not be accepted. Any illegible, incomplete or fraudulent entries will be rejected. No purchase is necessary to enter the Competition but you must have an Internet connection and an Instagram account. Only one entry is permitted per person. MHDK will check for fraudulent entries when the Competition ends.

The Prize

1. There are 24 prizes to be won, consisting of different Moët Hennessy Champagnes.
2. The prize is as stated and is non-exchangeable and non-transferable. There is no cash alternative.

The Winner

1. The daily winner of the Competition will be selected by at random (by a computer process)] from all eligible entries and notified the day after participation.
2. The choice of the judge(s) is final and cannot be contested.
3. The winner will be notified via a notification through Instagram from the Balthazar Champagne Bar profile.
4. The price is available to be enjoyed at Balthazar Champagne Bar at Ny Østergade 6, 1101 København, until 31st of January 2023.

7. The winner will be required to show valid identification and proof of eligibility and age at Balthazar Champagne Bar before receiving his/her prize. If for any reason the prize winner does not provide the requested information or is not eligible for the prize, MHDK will remain the owner of the prize.

General

By entering the Competition, participants agree to have their Instagram account name featured in publicity materials relating to the Competition and participate in reasonable promotional activity as may be required by MHDK in respect of the Competition, without further reference, payment or other compensation.

The winner names, available through Instagram, will be collected and provided to Balthazar Champagne Bar Denmark in order to administrate and manage the Competition and it will be shared with MHDK's agents and Balthazar Champagne Bar only to the extent necessary for the prizes to be delivered to the prize winners. Participants' names will be collected and stored by Balthazar Champagne Bar and held in accordance with applicable data protection legislation. By entering this Competition, each participant consents to the use of their personal data in accordance with these Terms and Conditions.

MHDK reserves the right to modify, cancel, withdraw or suspend the Competition or these Terms and Conditions in whole or in part, at its sole discretion, at any time if circumstances beyond its control make this unavoidable. MHDK is not responsible for any condition, circumstances, losses, failures or delays caused by events beyond its control.

To the fullest extent permitted by law, MHDK excludes liability for any damage, loss, injury or claims incurred by a participants' entry into the Competition or their acceptance, receipt and/or use or misuse of a prize. Except as otherwise required by applicable, law, MHDK accepts no responsibility or liability for any entry or claim which for technical or other reasons is unsuccessful, lost, incomplete, late, damaged, illegible, corrupted, misdirected or faulty.

They will be moderated daily and any content, suggestions or names deemed by MHDK to be inappropriate, offensive, obscene, defamatory, insulting, violent, disrespectful or upsetting will be removed. Any such entries, comments or posts will not constitute valid entry into the Competition. Persistent commenting of such nature will see the offending user blocked from the page and disqualified from the Competition.

Participants acknowledge that Facebook and Instagram shall not have any liability to them in connection with the Competition.
